Project Spotlight: USDOT Multi-Modal Research Program Regional Workshop: Best Practices in Bus Rapid Transit (BRT) Within an Integrated Context



On October 21 and 22, 2015, the USDOT/JPO and the NYSDOT held a workshop on integrating Bus Rapid Transit (BRT) with Integrated Corridor Management (ICM) and Regional Multi-Modal Travel. The I-95 Corridor sponsored part of this event held over 1 ½ days. This workshop focused on a multimodal approach with emphasis on needs, the traveler and balance of mobility for all modes.

The workshop began with a BRT "primer" during which differences between BRT and BRT "lite" were discussed, infrastructure and vehicle requirements explored, lessons learned from Connecticut and Los Angeles were highlighted, and implications for New York were discussed.

BRT Operations within a Connected Vehicle (CV) Environment was the focus of another session during which updates were provided on connected vehicle (CV) transit applications and ITS-JPO's ICM research. In addition, how the CV transit research affects BRT deployment was discussed.

BRT Operations within an Integrated Corridor Management Environment was highlighted. Participants discussed how best to integrate BRT operations within an ICM environment and explored the value proposition for both the transit and traffic management sides.

What's New in Traveler Information: FHWA Issues Next Gen Traveler Info Report

We are at a transformative time in the transportation industry including the field of Traveler Information. Many state transportation agencies are reassessing their role in traveler information based upon the offerings from the private sector. The Federal Highway Administration published a report (FHWA-HOP-15-029) in this area titled **Next Generation Traveler Information System: A Five Year Outlook** Final Report (dated August 2015). This report summarizes trends including the proliferation of big data in traveler information and it provides recommendations for public sector agencies based on these trends including:

- 1. Assess your agency's role in providing traveler information now and on a regular basis as changes are occurring in the industry.
- 2. Link together business and technology processes to ensure that your agency can quickly adapt to changes in the private sector and with the needs of your customers/traveling public.
- 3. Assess your agency's goals as a Transportation Network Management provider. Make sure they are still on point and that your efforts are focused on meeting your agency's goals and objectives.
- **4. Build a roadmap to achieve your agency's traveler information goals and monitor the progress.** Look at the tasks undertaken within your agency and those that may be done by a consultant. Continue to review the services/tools you provide to confirm that you are meeting your goals.
- 5. Standardize! (enough said)
- **6. Measure** determine the costs of providing data and services to your customers/travelers and determine if and how the data is being used. This step is imperative in making data driven decisions.
