I-95 Coalition Intermodal Freight and Passenger Movement Committee Co-Chairs

Thank you again to those who could participate on yesterday's I-95 Corridor Coalition Intermodal Freight and Passenger Movement Committee webcast. For those who were unable to attend, this memorandum and attachments will provide you background on the information presented and discussion.

- February 3, 2014 IFPMC Webcast Slides: The attached slides include information on the program activities currently underway by our Committee, the status of our proposed submission of comments to the Proposed Rulemaking on the Primary Freight Network and development of the Intermodal Committee work plan submission for Coalition Executive Leadership consideration.
- 2014-2015 Call for Work Plan Project Ideas: As noted in the webcast presentation and slides we are soliciting project ideas for our Committees' efforts over the next work plan year (July 1, 2014 – June 30, 2015). You should consider the following (see attachments) in submitting your project ideas:
 - a. The I-95CC Executive Guidance
 - b. Project Idea form for submission of your project ideas Please note: Forms are due no later than March 14, 2014. If you wish to discuss or have questions about project ideas or the project submittal form, please don't hesitate to contact our Committee Program Coordinator, Marygrace Parker at i95map@ttlc.net or 518-852-4083.
- 3. Development of Work Plan. In considering potential work plan ideas, please don't hesitate to propose ideas that you feel may assist you, our members, in advancing your work related to the movement of goods and people in our Corridor. To prompt some thoughts, some prospective work plan idea areas were included in yesterday's webinar. You might take note of Slide 40 as you think about potential 2014-2015 Workplan Project Ideas such as:
 - a. Electronic Credentialing/Permitting -- is there some coordination/ information sharing the Coalition can do?
 - b. Truck Rollover and Related Safety Applications is this an area to share some best practices on what states are doing?
 - i. e.g., Curve speed warning especially on off-ramps and sharp curves
 - c. Smart Roadside/Wireless Truck Inspection/CVII is there further work we should be doing in the Corridor to help get these things more integrated?
 - d. Continued Coordination among states for planning for projects that cross jurisdictions in freight corridors (such as freight flow data along the Corridor including both truck and rail data)
 - e. Data -- is it time to look at a "freight elements database" for states to share information (e.g. looking at what we have done in the past with projects such as the Coalition's Integrated Corridor Analysis Tool (ICAT) and the Vehicle Probe Project (VPP)?

- f. Several additional project ideas briefly discussed during the webcast were:
 - i. Continue coordination efforts to expand such programs as Truck Parking, CVII, and Significant Events Coordination
 - ii. Updating information on truck and rail chokepoints and bottlenecks in the Corridor
 - iii. Corridor-wide Freight diversion study, to promote intermodalism (truck-to-rail diversions; also perhaps include key airports and marine ports/"hubs")
 - Panama Canal impacts One such freight diversion that could be studied is the 2015 widening of the Panama Canal which has the potential for major impact away from long haul trucking (and rail) to regional haulage.
